Annex III, Page 1 of 1 Resolution to (Re)Create Faculty Senate Committee on Student Rights and Responsibilities

WHEREAS, the Faculty Constitution authorizes the Faculty Senate, by resolution, to establish standing and special committees, and

WHEREAS, West Virginia University's Office of Student Conduct requested faculty involvement in issues related to their purview, and

WHEREAS, the WVU Faculty Senate seeks to assist the University in assessing and understanding issues of student conduct and faculty relations to students, and

WHEREAS, the Faculty Senate does not presently have a committee tasked with assisting the University in this issue area, therefore be it

RESOLVED, that the Faculty Senate Student Rights and Responsibilities Committee is created as a standing committee for the two-year term ending June 30, 2024, unless sooner altered or terminated by resolution of the Faculty Senate, and be it

FURTHER RESOLVED that the Faculty Senate Student Rights and Responsibilities Committee shall present a report to the Faculty Senate no less than annually, and be it

FURTHER RESOLVED that the Faculty Senate Student Rights and Responsibilities Committee be charged with undertaking the following set of actions:

(1) Provide support and assistance to the WVU Office of Student Conduct, especially with regard to issues of student support, conduct, and academic integrity.

(2) Survey faculty with regard to their interest and willingness to serve as advisors to both the Office of Student Conduct and students engaged with that office.

(3) Define and implement a process to let faculty advise/mentor students engaged with the Office of Student Conduct, including the Office of Academic Integrity.

(4) Participate in annual training on the Student Code of Conduct; Title IX; the Academic Integrity Policy; and Board of Governor's Rule 1.6. Working with various stakeholders (including, but not limited to, the Office of Student Conduct and Office of Academic Integrity) suggest training for relevant faculty groups and sub-groups.

(5) Research and report on aspects of faculty involvement in issues of student conduct at other peer institutions and make recommendations as to faculty involvement in those issues at WVU based on that research.

(6) Not less than every five years, review and make suggestions to the Dean of Students about proposed changes/amendments to the WVU Student Code of Conduct.

(7) Report back to the Senate and Faculty issues of concern and information relevant to faculty on subjects related to this charge.

(8) Annually review and assess the scope of the committee and modify the committee charge, as needed.

(9) Address in a timely fashion other issues pertinent to the charge of the committee.

Change to the Committee on Committees, Membership, and Constituencies Charge

To ensure that the three campuses are being represented on Senate Committees, the portion of the Committee on Committees, Membership, and Constituencies' Charge that describes the Procedure for Populating Committees is being modified to include the statement in bold:

The following criteria will be incorporated on designated committees:

Outgoing committee chair's feedback and chair-elect's feedback regarding the re-appointment of current committee members;

Specific number of senators/non-senators required as designated by the Senate;

Balance between junior and senior faculty;

Balance among the various schools and colleges.

Balance among the various schools, colleges and campuses

The Library Committee is charged with undertaking the following actions:

- 1. Collaborate with the Libraries on policies, procedures, and services that support the university's teaching, research and service missions including access to materials, collection development practices, instructional and research services, open access publishing initiatives such as the Research Repository, and funding.
- 2. Assist the libraries in advocating for campus-wide approaches to scholarly publishing that will enhance access to and sustainability of published scholarship.
- 3. Engage with WVU researchers in all areas of scholarly communications including open access publishing, author rights and copyright, data management, and digital publishing.
- 4. Work with the Libraries, Office of Research, Teaching and Learning Commons, the Provost's Office and others as may be appropriate to improve scholarly communication services and initiatives available to instructors and researchers.
